Thursday 22 January – Thorne Harbour Health has announced the appointment of Chad Hughes as its next Chief Executive Officer.

With more than 25 years' experience in global and community health, Chad Hughes has worked internationally to deliver public health programs focused on HIV, drug and alcohol harm reduction, and LGBTIQA+ health. He has served on numerous boards and advisory committees, including Thorne Harbour Health's Board of Directors from 2014 to 2020.

"Thorne Harbour Health has an incredible history of leading the community response to HIV and expanding that legacy to meet the broader and evolving health needs of our communities," said Chad Hughes.

"It is truly an honour to step into the role of CEO. I look forward to working alongside our communities, partners, and staff to advance the health and wellbeing of LGBTIQA+ people and people living with HIV."

This announcement follows a rigorous recruitment process after longstanding CEO Simon Ruth stepped down in October 2025 and former Director of Services (2014-2018) Kent Burgess returned to serve as interim CEO.
